The Arizona Association of Defense Counsel (AADC) is a non-profit association of legal professional established in April, 1965. The AADC is comprised of defense attorneys from all backgrounds who practice primarily in the area of civil defense litigation. Membership in AADC is open to any attorney who is admitted to the practice of law in Arizona and who practices a substantial amount of defense litigation.

Annual membership categories are as follows:

- Individual Private Sector Attorney - \$200
- Individual Corporate Counsel or Government Attorney - \$100
- Group Corporate Counsel/In-House Counsel (up to 9 attorneys managing AZ litigation) - \$650
- Large Firm Membership (20+ attorneys practicing at the same firm, includes a seat of the AADC BOD) - \$3,300
- Medium Firm Membership (10-19 attorneys practicing at the same firm) - \$1,700.00
- Small Firm Membership (5-9 attorneys practicing at the same firm) - \$850.00
- Retired Attorney - \$50.00
- Attorneys Practicing Less Than 1 Year – Free
- Law School Students - Free
